Facility State Code	State code associated with facility
Facility County Code	County code associated with facility
Facility Congressional District	Congressional district in which facility is located
Facility Name	Name of facility
Facility State	State in which facility is located
Service Provided	Type of facility
Funding Type	Indicates transaction type, according to the following categories:
	Direct Loan Only
	Guaranteed Loan Only
	Direct Loan and Grant: combination of Direct Loan plus Grant award
	Grant Only
Obligation Status Code	Indicates the status of the obligation, according to the following categories.
	359: Closed. Status unknown.
	360: Closed. Multiple advances and/or interim financing are being used. Construction phase is in process.
	361: Closed. Construction phase is completed or purchases with loan/grant/guarantee funds accomplished.
	401: In operation. Planned development is substantially complete and facility is in operation. Borrower loan repayment is on or ahead of schedule.
	402: In operation. Final Inspection completed for direct loans. Loan Note Guarantee is issued for guaranteed loans.
	405: In operation. Grant status code used to code grant only RD funding, and the grant agreement is in effect.
	408: Transferred and assumed. Facility has been transferred to a new borrower who has assumed the loan as an eligible borrower. Facility is in operation.
	409: Transferred and assumed. Facility has been transferred to a new borrower who has assumed the loan as an ineligible borrower.
	410: In operation. Problem solved and borrower may be removed from this status and placed in status 402 after it has been determined that the problem is not likely to reoccur.
412: In operation. Portion of RD loan/grant/guarantee has been determined unauthorized with satisfactory repayment arrangements made.

Variable	Description
	413: In operation. The entire RD loan/grant/guarantee has been determined unauthorized with satisfactory repayment arrangements made.
	496: Grant status code. Used only when servicing is no longer required but the grant still needs to be monitored; e.g., the loan has been satisfied but the remaining grant needs to be monitored.
Award Status	Indicates award status according to the following categories: Obligated/Not Yet in Operation: the loan/grant has been obligated but not yet closed, usually because the facility is still under construction. This is an active obligation. Closed/In Operation: the loan/grant has closed and the facility is currently in operation. This is an active investment.
Obligation Date	Date that award was obligated
Obligation Amount	Amount of award obligation
Total Development Cost	Total development cost of facility
Date Loan Closed	Date that loan was closed
Leveraged Loan Indicator	Indicates whether loan was leveraged by private sector investment
Locally Produced Food	Indicates whether the facility is associated with the USDA Know Your Farmer, Know Your Food initiative
Borrower Name	Name of borrower or grantee
Type of Borrower	Indicated whether the borrower or grantee is a nonprofit corporation, public body, cooperative or Indian Tribe
Faith Based Desc	Indicates whether the borrower or grantee is a faith-based entity
Population Count at Obligation	Population count of facility's service area, according to Decennial Census at time of obligation
Median Household Income at Obligation	Median household income of facility's service area, according to Decennial Census at time of obligation
Projected Nbr Hispanic Served	Projected number of Hispanic people to be served by the facility at time of application
Projected Nbr Black African American Served	Projected number of Black/African American people to be served by facility at time of application
Projected Nbr Asian Served	Projected number of Asian people to be served by facility at time of application
Projected Nbr Hawaiian Pacific Islander Served	Projected number of Hawaiian and Pacific Islander people to be served by facility at time of application
Projected Nbr Multirace Served	Projected number of people of Multiple Races to be served by facility at time of application

Projected Nbr Amer Indian Alaskan Native Served	Projected number of American Indian and Alaskan Native people to be served by facility at time of application
Projected Nbr White Served	Projected number of White people to be served by facility at time of application
